### Local Elections May 2023 – From the Chair

Parish councils follow the same electoral cycle as district councils. At least ten people need to put their names forward officially to stand in May 2023 to serve Kegworth North (part of district ward 'Daleacre Hill') and Kegworth South (district: 'Kegworth') for the 2023-27 term.

Resignations during the four year term are more common among parish councils, but most remain remarkably stable. This has not been the case in Kegworth. In 2019, nine people came forward initially, leaving just one co-option to make afterwards. However, within a year, half of those elected had resigned. That rate of turnover has continued, to the detriment of Kegworth and democracy.

In the next few months, we need a team of people to emerge who will seek nomination by the end of March 2023. We need at least ten nominees. If eleven or more come forward, an election in Kegworth would be triggered. Should there be less than seven nominees, projects that Kegworth could pursue for the 2023-27 period might be limited, because 'General Power of Competence' would be lost, thus lowering our status in the district. Please do not wait any longer. Start planning now and make your intention known.

#### **Jubilee Competition**

As you know, we received funding from the Queen's Platinum Jubilee Grant from North West Leicestershire District Council to run our Jubilee Competition. Thank you to all the traders that took part. The windows looked great.



## Kegworth's 'Public Realm' Project

We are pleased to report that an option for a new cycleway on London Road in Kegworth is currently being considered by the Council. This is the only viable option in light of the underlying aqueduct water supply.

The proposal is for a cycleway which would start on the West side of London Road close to the junction of Whatton Road/London Road. The cycle route would cross over New Brickyard Lane and then an uncontrolled crossing would be provided shortly before the existing western retaining wall. The crossing is necessary due to major service infrastructure in the area. A priority give-way option at this point is also being considered. The cycle route would then continue off carriageway down the east side of London Road until it meets with the existing cycle infrastructure on the bypass roundabout.

North West Leicestershire District Council have had confirmation from Leicestershire County Council that they will be able to undertake the detailed design and works for both the cycle route and the Market Place, which is good news for Kegworth.

#### **Local Plan Consultation**

The Chair and Vice Chair of Kegworth Parish Council have formed a new collaboration with the parish councils at Lockington-Hemington, Castle Donington, Long Whatton-Diseworth, and Breedon to influence the new NW Leics Plan to 2040.

This includes discussing proposals for housing targets, employment sites, warehousing, and Freeport land owned by EMA/SEGRO to the South of the A453. The group has raised the need for infrastructure ahead of development, environmental protection, employment needs, affordability of new housing, and the potential

#### **Assets of Community Value**

Kegworth Players Youth Arts group have made a nomination to NW Leics District Council for the Methodist Church to be designated as an 'asset of community value'. Kegworth Parish Council has written in support of this application.

This process allows community groups the right to ask the Local Authority to list certain assets (property or land) as being of value to the community.

If an asset is listed and subsequently put up for sale, designation gives community groups a six month option to acquire the asset. This gives communities time and an increased chance of saving much-loved local facilities. It doesn't unfortunately mean that the community purchase is guaranteed because the sale process remains competitive.

## Covid Commemorative Benches



NW Leics District Council have offered to provide four Covid commemorative benches for the village free of charge. After discussion with the Friends of Side Ley Park, it has been agreed to put two benches in the park. The two other benches will go outside the school. These will be installed in due course.

#### Did You Know..?



We have recently been successful in obtaining a grant from the East Midlands Airport Low Carbon Energy Fund to upgrade the lighting in St Andrew's churchyard. The new lighting will support the Council's desire to be more environmentally sustainable.
